Event Qualification:

- All President's Team
- PLUS any Fully Qualified Supervisors who Qualify for the E&A 2026 AWT Promotion and earn a minimum of 2,500 R/O in one month from November 2025 through October 2026 Volume Months (cheques paid December 2025 to November 2026)
- New GET Team may achieve the minimum required 2,500 R/O in one month even during their 3-month qualification to GET Team, as long as their new GET Team status is achieved by 1st November 2026 (October 2026 Volume Month).
- The last month to qualify for the E&A 2026 AWT Promotion is October 2026 (Volume Month).
- In order to attend the event all qualifiers need to purchase the 2026 Europe & Africa FPTR ticket/s. Tickets sale will be announced at a later stage.
